Town establishing Culture and Wellbeing Task Force

The Town of Strathmore is announcing the establishment of a dedicated Culture and Wellbeing Task Force, following approval by council during the June 7 regular meeting of council.

The goal of the task force will be aimed at fostering a healthy, welcoming and inclusive local community, and will help guide the Strathmore Family and Community Support Services (FCSS) with the implementation of two grant-funded services.

These services will be the Strathmore Welcoming Initiative, funded by the Government of Alberta, and the Connected by Culture Project, funded by the Canadian Mental Health Association (CMHA).

"The task force gives us the opportunity to actively involve the community to develop programs and execute efficient use of the grant money," said Melissa Masse, community support coordinator with Strathmore FCSS, who also brought the taskforce proposal before Council. "We're looking for the advice and expertise of Strathmore's residents to help decide what programs Strathmore will benefit from most - ensuring these funds will create meaningful and lasting change."

Town of Strathmore administration was successful in the application to the Government of Alberta and was awarded funding

In the fall of 2022, Strathmore Town Council supported a grant application to the Alberta Government Settlement Integration and Language Projects Program (SILP) to support initiatives to increase the community's social services capacity.

This was also intended to meet the needs and lived experiences of newcomer communities, as well as to develop a welcoming and

in the amount of \$258,000 to be utilized over a 24-month period.

"Administration was also successful in receiving funding in the amount of \$12,950 from the Canadian Mental Health Association (CMHA) to support community wellbeing that leverages the strengths of Strathmore's unique culture and heritage," said Masse. "Both grants have significant budgets to support community events such as the Alberta Culture Days, as well as additional ongoing programming and initiatives."

Isaac Taylor a Class Act

Isaac Taylor of Strathmore High School (SHS) is the Strathmore Times Class Act Award winner, as well as the Ken May Memorial Award winner for 2023.

The Strathmore Times Class Act Award is presented to an individual who has extraordinary accomplishments in one or more areas outside of academics, as well as who maintains a strong academic standing.

The student's quality of character is also considered, as it sets them apart or distinguishes them within their school and community.

"For the Class Act award, that was mostly outside of school. That was a lot of practicing and a lot of music training," said Taylor. "My mother is very musical, so she put us all in music training at a very early age. I also took inspiration from my brother – he started violin and I wanted to be like him."

Taylor has been involved in music with the piano and violin for nearly 14 years, and achieved the Level 10 Royal Conservatory of Music standing for both instruments in 2021.

This is the highest standing of music awarded by the Royal Conservatory of Music, and as was presented during the award ceremony, was comparable in achievement to that of a bachelor's degree.

His awards were presented to him on June 8 during the annual SHS student award ceremony, where recipients, teachers, and sponsors gathered to honour student achievements.

Taylor, as well as his peers, were not informed of their awards prior to the ceremony. They were simply requested to be in attendance.

"I was just notified through an email about a week prior to this and I was not told which awards or how many I was up for – just that I should show up," said Taylor. "I am pretty excited because I was not really expecting the drama award because there is a lot of other talented performers who I did not know if I could compete with. I was pretty excited because I had applied for that scholarship."

Taylor has previously participated in both the Airdrie and Strathmore Music Festivals, has received several other scholarships, as well as a provincial recommendation for music composition and violin.

"I am planning to do music performance, specifically piano performance through post-secondary, and then I want to go into composition after that," added Taylor. "I would say that professionally, I would mostly like to do performing and touring. That is kind of what I want to pursue."

Taylor advised other students who may have similar aspirations that his level of achievement is not something that has come lightly, and has required a tremendous amount of diligence, initiative, self-control and discipline. It is not something that can simply be reached through complacency.

Former Strathmore resident awarded **Governor General Silver Medal**

University of Lethbridge student, Jonathan Le May, who originally hails from Strathmore, has been awarded a Silver Medal of the Governor General.

The accolade is presented to the student with the highest academic standing at the undergraduate level. Le May has just graduated with a Bachelor of Science with a major in neuroscience.

"I was surprised because I had actually applied for another award. (The university) has their own medals that they give out, so I was assuming that I had received an email about that award. When I got on the phone with the president of the university, he informed me I had gotten the Silver Medal," said Le May. "It was actually a fun process. I got an email from the secretary of the president asking if I could have a quick phone call with him ... I was really excited because I did not know about it. I felt fancy getting a phone call from our president."

Le May explained his interest in neuroscience began during his time in high school with anesthesiology and the idea of consciousness.

This curiosity led to a desire to develop a better understanding of the brain, which brought him to Lethbridge.

"I was reading some textbooks in high school during reading period and I would just go through all these different anesthesiology books and it was really interesting to me, the idea of consciousness," he said. "Are we conscious, are other animals conscious, and what does that really mean? Especially because when we sleep, we are unconscious and stop thinking and processing everything for a little bit, then you wake up and

everything is normal again."

Le May spent a significant portion of his undergraduate degree working in a lab with Dr. David Houston, and completing five independent studies for an honours thesis.

The ceremony to receive his award was at the conclusion of his convocation. Le May explained after receiving his bachelor's degree he was invited to remain on stage to receive his silver medal.

"It was really significant to me to be recognized for the hard work that I had put in over the past four years and to be able to receive the award knowing the work that was put in was really special to me," he said.

Le May has applied to enter into graduate studies, continuing at the University of Lethbridge, to continue in the same lab he has been involved with for the past several years. He plans on pursuing a master's degree in neuroscience, and apply for medical education during his tenure.

Siksika Health Services announcing expanded program to combat diabetic foot ulcers

Siksika Health Services, in partnership with Orpyx Medical Technologies and GMAK Consulting, are announcing the launch of a second pilot program to improve foot health for diabetic nation members.

Following the success of the first program, which involved 35 Siksika members, the partnership is aiming to expand efforts to prevent diabetic foot ulcers and improve overall foot health for people living with Type 2 diabetes.

Additionally, a comprehensive evaluation of the effectiveness of remote patient monitoring and Orpyx's shoe insoles will be conducted in the community.

"We're excited by the opportunity, and also the possibility for this to have a meaningful and important impact on our people's health," said Tyler White, CEO of Siksika Health Services (SHS). "It's important that we have these types of advanced services, that we have partnerships that are like-minded, that have the same vision, and the same purpose as we move forward together."

pansion of our partnership with Siksika Health Services, a collaboration that has already shown promising results in providing supportive remote care and improving foot health within Siksika Nation. Our initial pilot has showcased the tremendous potential for improving the lives of individuals facing the unique challenges of living with diabetes," said Dr. Breanne Everett, CEO and founder of Orpyx. "By joining forces with SHS, we have worked together to gain invaluable insights, enabling us to tailor our solutions even more effectively to the needs of Siksika members. This partnership exemplifies the power of collaborative, human-centered innovation, and we are excited to see where we can take this with the next phase of the program."

The organization of in-person community gatherings on Siksika Nation serve as a platform for providing culturally appropriate support for participating nation members.

During the initial 24-week pilot, Siksika Health Services has reported that only one participant with a long history of recurring diabetic foot ulcers has developed a new wound.





Strathmore local provincial high school rodeo champion

Strathmore local saddle bronc and bareback rider Clay Greenslade claimed the provincial high school rodeo championship June 3-4 in Stettler.

Competing in three rounds for saddle bronc during the rodeo, he claimed two second place scores, and a first, which gave him the highest overall score amongst competitors.

"It was a pretty good experience this weekend ... this is my first year in high school rodeoing. Before, I have done junior associations and a couple years ago I was in junior high rodeo," said the 16-year-old.

Clay explained he has been involved with saddle bronc for the past five years, getting into the sport after starting out riding horses bareback.

His father, Andy Greenslade, said he is proud to see Clay advance in his skill level and begin to collect his accolades.

"It has been a good experience since we have been watching him grow in the sport over the last five years and he has been accomplishing his goals," said Greenslade. "Clay trains at home, he has a trainer through the Canadian Pro Rodeo Sports Medicine. He has gone through their training program; we have a bucking machine here at home, he is constantly in the gym, and he goes to rodeo schools."

Greenslade added developing skill in rodeo sports is effectively a numbers game, and getting on as many horses as you can to learn and improve.

Previously being involved in pro rodeo as a bareback rider himself, Greenslade decided to hang up his spurs when Clay was an infant, as he did not want to constantly be on the road at the time.

Over the summer rodeo season, Clay intends to attend several amateur associations and rodeos across the province to compete in bareback and saddle bronc.

Come August, he will be in Brandon, Man. for the Canadian High School Rodeo Finals.

"I am always excited about it and I just always want to keep doing it," said Clay. "I want to be the best that I can be and just keep having fun."

Back in 2021, Clay also claimed the senior all around world champion title from the YETI Junior Roughstock World

Langdon homicide

On May 26, at 12:10 p.m., Strathmore and Langdon RCMP responded to a 911 call of an assault at a residence in Langdon. Upon arrival, a female was located unresponsive. She was taken to a Calgary hospital in serious condition.

A 31-year-old male, a resident of Langdon, was arrested at the scene.

On June 7, the female victim succumbed to her injuries and died in hospital. She was taken for an autopsy at the Chief Medical Examiner's office in Calgary on June 8.

Alberta RCMP Major Crimes Unit have taken carriage of this investigation, with the assistance of Strathmore and Langdon RCMP, and the RCMP Forensic Identification Unit. The investigation continues and charges are pending. An update will be provided when further details can be released.

Senior's Week returns to Strathmore

Senior's Week returned in Strathmore last week, with a host of different activities for local residents to participate in, with several things to do taking place each day.

According to Audra Anderson, a resource navigator with the Strathmore Wheatland Wellness Resource Project, the events which took place during Senior's Week were largely community organized.

"It is just a group - a community collaborative of people who get together who want to be a part of Senior's Week and then everybody just asked to make up their own events," she said. "We try to spread out the events so they are not overlapping, but anybody can join. Most of the activities are free, some of them require registration and some of them are paid events, but we try to have as many events as we can that have no fee attached to them."

During the first day of Senior's Week, for example, a dropin shredding event was hosted in the parking lot of the Strathmore Municipal Library for seniors to recycle old documents and the like.

Simultaneously, coffee and snacks had been made available in the program room of the library. Seniors who attended were also able to interact with a variety of local organizations and initiatives who wanted to be a part of the event.

Other activities which took place throughout the week included a zentangle class at the Wheatland Society of Arts, a suncatcher making class at the library, a strawberry tea at the Happy Gang, as well as free access to the walking track at the Strathmore Motor Products Sports Centre.

According to Anderson, there has overall been an increase in attendance of Senior's Week events as there are less concerns regarding COVID-19, and more people have become aware of the available activities.

Additionally, the amount of people and organizations hosting events for seniors to attend is also gradually increasing.

"We have seen a few increases in our senior events ... (and) an increase in people attending events. I think it does organizations being involved."

She regarded that at the drop in for coffee and snacks, which took place June 5, the event was well attended pretty much as soon as the doors opened.

"It has been quite busy," she said. "It has been a steady stream of people coming and having coffee and chatting."

Information and scheduling had been posted online for the duration of Senior's Week, and is likely to be repeated next year.

Also, wear long-sleeved shirts and long pants and good footwear....no sandals. If you have a tick on you, use tweezers to pull it to being careful not to squeeze the body. Check the site *tickcheck*. com for information on identifying ticks.

Health Canada is making changes to those nutrition labels on food packages. They will be easier to read with a larger font size. The serving size will be changed to reflect what is normal consumed per serving. Potassium is added to the list of nutrients because of its importance in maintaining blood pressure. And coming in 2026, labels on the front of package with warnings like "High in Saturated Fat" or "High in sugar".

Hematuria: heme = blood; uria =pertaining to urine. Microscopic hematuria is picked up only under a microscope since it's not visible to the naked eye. Macroscopic hematuria is blood in the urine that you can see and is the more urgent of the two, Any time you see blood in your urine, see your doctor.

Are you traveling this summer? Ensure you have enough of your Rx medication to last the trip. Check to see if the country you're visiting requires any special immunizations. Also check to see if there are any rules about how much narcotic-containing medication you can carry with you. Sometimes there is a limit. Cannabis? Leave it at home. 



Wheatland Crisis Society rebrands as True North

The organization formerly known as the Wheatland Crisis Society announced its official rebranding as True North on June 6 at the Legacy Farm.

Newly minted, True North hosted an

event to both formalize the announcement, as well as to celebrate those who have been important to their shelter, and the volunteers and staff who operate it.

"We want to celebrate them, and we are also introducing our new name change. We have been in the community for 30 years as Wheatland Crisis Society and felt it was time for our new rebrand," said Carol Manson McLeod, executive director of True North. "It has been almost a year of thinking about this and working with our board in the community, and talking to people about who we are and what we are."

Manson McLeod explained there were, overall, three reasons for the organization to have decided on a name change.

"One is the term, 'Wheatland Crisis Society.' In a trauma-informed response, if I say I am going to a crisis society, it brings what I am already going through more to the forefront. We wanted a name that was more friendly and more inviting to our clients who are coming in to us."

Additionally, regarding the name change, she explained, is that the shelter services more people than just those who are already residing within Wheatland County. The idea now is to prevent the misconception.

Manson McLeod added the team feels "True North" as a name suggests pointing an individual in the right direction, and to chart their own path going forward.

As a next step, which was also unveiled during the announcement event, True North will be working to develop affordable housing units for its clients who age out of being able to stay at the shelter from their three-week grace period.

"The sad thing is that we are still here after 30 years helping people continue to flee domestic violence. It is sad that




we are still here, but we are committed to being here," said Manson McLeod. "It is an unfortunate necessity, but I think what has been happening over the last several years is that we have been growing our definition of domestic violence. At one time, I think people thought it was only physical violence, but it is also emotional and sexual abuse, and I think people are becoming more aware of what domestic violence is, and the fact that they can indeed get help and they can flee from it."

During the rebranding event, True North also received a \$5,000 contribution from the CGC to aid in their continued efforts to support the community. True North has launched their new website and has updated their online information. More info about how to access their services or support the or-

Expressions The Dance Gallery (EDG) hosted its annual aerial showcase on June 11, making use of their newly acquired studio space to host and perform for the local community.

Michelle Murdoch, office manager for EDG, said the studio and their performers were thrilled to be able to perform locally, particularly in a space properly rigged for the show.

"Our aerial showcase always had to be separate from our other classes because we have all the apparatuses, the silks and the hoops. When we do our year end showcase, we used to do it in Calgary because a lot of the theatres can accommodate that," she said. "Last year, we were able to rent equipment to do it in the park when we did it at Kinsmen. This year, because we have this brand-new studio ... we are able to do the showcase here. That is really exciting."

Murdoch described the aerial showcase with likeness to what you might see at a circus, with performers utilizing suspended equipment such as hoops or silk drapes to complete a choreographed routine.

The 33 performing athletes ranged in ages from six, all the way to 18, having trained with aerial certified instructors since September for this show.

"We were really excited. This was the first event that we have held at the studio, because we just moved in Decem-

ber," said Murdoch. "We were really excited to offer this because performance wise, there is nowhere in Strathmore that has a venue that we are really able to use with a real stage."

The event was ticketed, and able to seat 60 people per show. A showcase was performed once, starting at 1 p.m. and a second time beginning at 3:30 p.m. Both shows were nearly, if not completely sold out by the time the curtains rose.

EDG also offers classes in tap, jazz, ballet, hip hop, acrobatics, musical theatre, contemporary, and lyrical performances. These showcases are generally hosted separately from the aerial performances due to the difference in required equipment and apparatuses.

Sunday's performance marked the end of the season for the aerial dancers, though for many of Expressions' other classes, the showcase to look forward to will be hosted at the Glenmore Christian Academy, June 17, for their 40th season.

"This weekend was just the beginning of the year end celebration. Because of safety concerns, we are only allowed to have about eight students per teacher for our aerial classes, so it is one of our smaller programs," said Murdoch. "Our other showcase that is going to be on the 17th, classes are a lot bigger and they range from 2.5 year-olds to 18, performing many different styles."




Lindsay is predeceased by his father Frederick, his mother Doris and brother Rick.




